With reference to the INDOCERT inspection of your unit on 03/12/2023 and the certification committee meeting held on 29/05/2024 we would like to bring to your notice that your unit complies with the INDOCERT Organic standards for Non- EU Country Operators" (considered equivalent to Council Regulation (EC) No. 834/2007 and Swiss Organic Farming Ordinance). The products may be labelled or marketed according to the certification status indicated in the attached "Certificate" provided that you meet the following conditions and agree with the imposed sanctions.

Based on the non-compliances the Certification Committee imposed the following sanctions:

Additional requirements to be maintained for certification:

- 1. Witness inspection of EU equivalent organic products processing is mandatory for issuing transaction certificates / Certificate of Inspection. The operator should arrange for additional witness inspection for the organic processing, if not witnessed during the initial /regular inspection. Operators must inform INDOCERT through mail at least 15 days prior to the start of organic processing
- For the processing of organic agricultural products for use as food/feed intended to the EU market, the operator should procure raw material (fresh/unprocessed products), from the suppliers certified by the EU equivalent Certification Body.
- 3. During every export of ETO risk products such as Sesame seeds and Turmeric/curcuma to EU countries, the operator should intimate INDOCERT prior to shipment for sampling and COI shall be issued only based on test results.
- 4. INDOCERT should take at least one representative sample of each consignment of pesticide risk category products also. INDOCERT will analyze the samples for the presence of pesticide residues in a laboratory accredited to the analytical methods used. INDOCERT will not issue the certificate of inspection (COI) before it has received and assessed the result of these analyses.

- 5. The operator must apply for label approval to INDOCERT before EU organic logo for labeling of certified products.
- 6. Operators should apply for Transaction certificates for every organic sale.
- 7. As per DGFT norm, a product will be allowed to be exported as an "Organic Product" only when accompanied by a Transaction Certificate issued by a Certification Body accredited by the National Accreditation Body (NAB) for Organic Products under the National Programme for Organic Production of the Department of Commerce.
- 8. In the case of export to EU countries, the operator should obtain a Provisional Transaction Certificate (issued thorugh EU TracesNT) before the consignment is shipped. The final export TC is required to be issued to the exporter within 45 days from the issuance of the provisional TC for the export of Organic products.
